Question 1

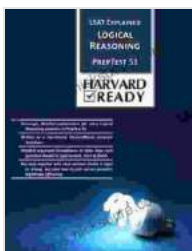

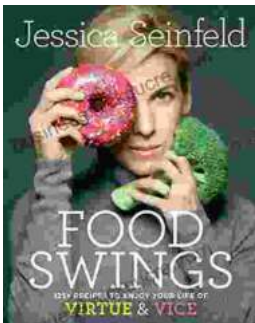
